






Overall, how effective has the Mercy University iHELP communication been in conveying program components and site supervision requirements? Check one.




















What prevented you from attending workshops provided? Check all that apply.








How helpful have the Mercy iHELP trainings and resources been for you professionally?

Comments

My only issue was I was not aware of this student's special programming until he called my attention to it. He had to explain it to me, as I interviewed him and he did not express he was in iHELP at that time. Regardless it was not an issue in terms of his performance and ability to get what he needed from this affiliation. He attended and participated in all assignments.

I think the program is good, would have liked to be more informed as this was my first student in the program that I had supervised.

I recall my OT student going online during her lunch hour to attend workshops; however, I was never explained the program or knew that it had anything to do with me as her supervisor. I went back into my emails and did see an invitation to a workshop but I was unable to attend at the time. I wish that I had been able to. However, I did not know that my student was involved in this program specifically except that I recall her attending these meetings on her lunch hour. The program was never explained to me specifically and/or how I can be involved. There was no communication to me about the program from the IHELP Mercy program.

Unfortunately, my trainee was more involved in gossiping and did not fulfill the internship task. When being coached, the trainee would shut down and avoid conversations; they did not receive much support from Mercy to address the behavior when reported.
